

ENEOS Asia Sepang MotoGP Survey 2017

Terms & Conditions

Eligibility

1. This contest is organised by JX Nippon Oil & Energy Asia Pte. Ltd. (“**Organiser**”, “we” or “us”, “our”), and commences on 10 October 2017 till 31 October 2017.
2. The Contest is free of charge. The Contest is **ONLY** open to legal residents in Bangladesh, Cambodia, Malaysia, Myanmar, New Zealand, Singapore, and Sri Lanka (“**Participants**”), except for the following:
 - a. Employees of Organiser, their advertising and promotion agencies and their family members and/or those living in the same household of each are not eligible; and
 - b. Representatives and/or distributors of the Organiser

Contest Mechanics

Participants that adhere to the following Contest Mechanism are qualified for the Contest. The Participants must:

2. Complete the survey by 23:59 (GMT +8) on 31 October 2017 (“Deadline”)
3. Any comments posted after the Deadline will not be entertained at all cost.
4. The Participants are allowed to submit multiple entries. However, the Participants will only be entitled to win based on ONE (1) entry.
5. Only Participants that fulfil each of the Contest Mechanism shall be eligible to win the Prize. Incomplete entries and/or Participants who failed to abide by the

6. TEN (10) winners (each shall be referred to as “**Winner**”) will be selected based on creativity at the end of the Contest Period.

9. The Winner will be contacted after the Announcement date at any time deemed appropriate by the Organizer via Facebook or any other mode of communication deemed appropriate by the Organizer. More details will be emailed to the Winner thereafter.

10. The Prize is not exchangeable and/or refundable by cash or any other benefit in kind.

11. The Organizer reserves the sole right and discretion to delete, remove, not consider or reject any submission(s) that is deemed by it to be improper or offensive in whatever nature.

We will respond to the Participant's request within the time prescribed by applicable law.

In any of the situations listed above, in order for us to comply with our security obligations and to prevent unauthorised disclosure of data, we may request that the Participant proves his/her identity by providing us with a copy of a valid means of identification.

We will keep Participants' personal data while we process Participants' personal data for the purpose set forth above, but if it is no longer necessary, we will delete Participants' personal data promptly.

By participating in this Contest, you consent to the Organiser's collection, use and disclosure of your personal data for the purposes and in the manner described above.
