

# ENEOS Malaysia Snap, Tag & Win Contest

## Terms & Conditions

### Eligibility

1. This contest is organised by JX Nippon Oil & Energy Asia Pte. Ltd. (“**Organiser**”, “we” or “us”, “our”), and commences on 27 October 2017 till 29 October 2017.
2. The Contest is free of charge. The Contest is **ONLY** open to legal residents in Bangladesh, Cambodia, Malaysia, Myanmar, New Zealand, Singapore, and Sri Lanka (“**Participants**”), except for the following:
  - a. Employees of Organiser, their advertising and promotion agencies and their family members and/or those living in the same household of each are not eligible; and
  - b. Representatives and/or distributors of the Organiser

In that event, the Organiser shall be entitled to redistribute the unclaimed Prize to the pool of reserve winners.

We will respond to the Participant's request within the time prescribed by applicable law.

In any of the situations listed above, in order for us to comply with our security obligations and to prevent unauthorised disclosure of data, we may request that the Participant proves his/her identity by providing us with a copy of a valid means of identification.

We will keep Participants' personal data while we process Participants' personal data for the purpose set forth above, but if it is no longer necessary, we will delete Participants' personal data promptly.

By participating in this Contest, you consent to the Organiser's collection, use and disclosure of your personal data for the purposes and in the manner described above.
