

# ENEOS Malaysia VR|46 Exclusive Bag Giveaway

## Terms & Conditions

### Eligibility

1. This contest (“**Contest**”) is organised by JX Nippon Oil & Energy Asia Pte. Ltd. (“**Organiser**”, “we” or “us”, “our”), and commences on 22 September 2017 till 21 October 2017.
2. The Contest is free of charge. The Contest is ONLY open to Malaysian citizens or residents residing in Malaysia as determined on the basis of possession of an NRIC, Dependent Pass, Working Pass or Student Pass (“**Participants**”), except for the following:
  - a. Employees of the Organiser, their appointed advertising and promotion agencies and each of their immediate families are not eligible to participate in this Contest; and
  - b. Representatives and/or distributors of the Organiser.

We will keep your personal data while we process your personal data for the purpose set forth above, but if it is no longer necessary, we will delete your personal data promptly.

By participating in this Contest, you consent to our collection, use and disclosure of your personal data for the purposes and in the manner described above.
